JOB DESCRIPTION – RELIEF SUPPORT WORKER

Cannock Learning Disabilities Service

Responsible to: Relief Staff Team Leader

The Role:

To provide individualised person centred support to people with learning disabilities living in their own homes or in supported housing; to enable them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.

Main Responsibilities/Duties

1. To develop and sustain warm and trusting relationships with service users. To promote the self-esteem, happiness and emotional health of service users.
2. To respect the person's right to privacy and to ensure that their dignity is maintained at all times.
3. To encourage and support service users in expressing their needs, views and concerns. To enable service users make choices and decisions and to participate as fully as possible in planning and decision making processes.
4. To respect and promote the rights and entitlements of people with learning disabilities, and to enable them to participate as fully as possible in their communities.
5. To be responsive to the individual needs of service users within the framework of their Person Centred Plans and to respond flexibly to changing needs.
6. To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
 - Social skills/relationships
 - Personal care & hygiene
 - Daily living skills
 - Using community resources and facilities
 - Social, leisure and work activities
 - Self-organisation and coping abilities
 - Personal safety

To achieve this through the provision of practical assistance, support, teaching, advice, role modelling, encouragement and positive feedback.

7. To support people who express their frustrations and needs through challenging behaviour by using appropriate strategies and interventions as specified by the Person Centred Plan.
8. To ensure that service users receive all necessary advice, care and regular health checks to ensure their physical health and well being. To promote nutrition, relaxation, exercise and a healthy lifestyle.
9. To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on the strengths, interests and aspirations of the service user. To enable people to access social, leisure, work and educational opportunities.
10. To enable service users to access developmental opportunities, new experiences and challenges, whilst not being exposed to unacceptable risks.
11. To assist service users in the administration and monitoring of prescribed medication in accordance with the Scheme's Medication Policy.

12. To observe and monitor the service users' emotional and physical well being and to inform relevant staff and agencies of any concerns or significant changes in their needs, behaviour and circumstances.
13. To take appropriate action in the event of unforeseen emergencies, ensuring that the Unit Business Manager and the Team Leaders is informed promptly.
14. To follow Health and Safety guidelines carefully and to alert the Unit Business Manager immediately of any concerns in relation to Health and Safety issues.
15. To contribute to project records and individual case files. To carry out and record all financial transactions involving service users within agency guidelines.
16. To carry out general administrative duties, housing management tasks and services as needed
17. To contribute to service users' reviews, through the provision of verbal and written reports and by attending Support Planning meetings.

Other

18. To notify Line Manager of planned whereabouts and to submit accurate timesheets weekly.
19. To provide regular verbal and written reports to colleagues. To accept support, supervision and guidance from senior colleagues.
20. To carry out all work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.
21. To comply with and to implement the Equal Opportunities Policy. To maintain confidentiality at all times, in accordance with the agreed policy.
22. To identify training needs in discussion with Line Manager and to attend training events and courses as required.
23. To observe any written policies, procedures and guidelines for good practice agreed by Creative Support.
24. To take on the role of shift co-ordinator when required.
25. All employees should be aware that due to the nature of work Creative Support undertakes there is a requirement to support service users with daily living skills and individual activities which will include moving and handling and may involve supporting people with personal care needs
26. In accordance with the Health and Social Care Act 2008, to actively participate in the prevention and control of infection within the capacity of the role.
